Siren Activation:

- The siren will only be activated for events that may impact Dawson County and the City of Glendive.
- The siren will be activated when a Tornado Warning has been issued by the National Weather Service for Dawson County and or the City of Glendive.
 - If a tornado is confirmed, the siren will be activated ad ran continuously until the event is over.
- The siren will be activated in the absence of a Tornado Warning if trained weather spotters and or reliable sources indicate a tornado is occurring or about to occur.
 - Immediately notify the National Weather Service of the report 1-800-775-5771 or 406-228-4042
- The siren will be activated when a severe thunderstorm warning is issued indicating wind speeds in excess of 70mph.

Monitoring of Warnings:

- Dawson County receives all warnings through the CJIN network in text format.
 Dispatch should review them upon receipt and see if Dawson County or the City of Glendive is in its path or not.
- Graphical format of warnings can be seen in various ways, especially with cell phone apps showing radar images and the warning 'box'. Three free recommendations include:

 - <u>NWSchat.weather.gov</u> (a communication tool between partners and the NWS)

Public Outreach:
