Public Hearing-Dawson County Budget

1)PUBLIC HEARING-FY15/16 BUDGE**t** Commissioner Gartner opened the meeting to public comment regarding the Dawson County Final Budget for FY2015-2016. He noted that they had received an email from the Republican Central Committee asking that the county commissioners that in lieu of the high tax evaluations to not increase the county budget.

Items added to the published agenda:

The following items were received after the agenda was published and were added to the agenda, Travel Request, Encroachment permit, Legal opinion regarding River Road Zoning, Health, Bloomfield School Health Contract, Action for Eastern Montana Workplan, and the last 4 items of correspondence.

Prior Meeting Minutes:

A motion was made to accept and approve minutes for August 18, 2015. The motion was seconded. All voted in favor. Motion carried.

Transfer of Interest- A motion was made to transfer funds from Interest Clearing fund to cover interest from investments to the appropriate designated funds in the amount of \$3,000.14 for the month of July 2015. Motion carried.

New Administrative Items:

2)SCHOOL BUDGET-DCC 15/16

School Budget-Steve Engebretson Supt of Schools presented the commissioners with the various school budgets noting that he had calculated all of the levies except for the college as he noted on the spreadsheet. He submitted what was presented to him from the college on the day before at 2:41 p.m. This was simultaneously submitted to the commissioners as well. He did not have all of the information to calculate the levy himself. The commissioners are aware he does not feel that they calculate the levy according to state code and include something for the oil and gas on each of the funds that actually receive revenue from oil & gas. Since it is not clear according to code who calculates this, the school or the Supt of Schools, he feels that an Attorney General opinion is needed. As they are aware, he previously worked with the college to calculate their mills, until last year when they couldn't agree on the inclusion of oil & gas revenue. He stated that he did include the college mills as calculated on his school levy sheet, but as he did not calculate it, that is the reason for the disclaimer in yellow on the sheet. Commissioner Kartevold stated that this happened last year and they had a year to work this out. Superintendent Engebretson stated that they did meet and came closer, but they've disagreed. "We tried, but it didn't work out." Commissioner Buxbaum asked when he last received all of the information to calculate mills. Engebretson: Two years ago. August of 2013. Commissioner Gartner, Do you have questions of the college? Did you use any estimate on the oil and gas revenue in your calculation? Kathleen Zander, Yes, there are 4 separate funds. We estimated in the debt service and adult education, none in the general fund or retirement fund. We received an attorney opinion on this and it is our choice that we are allowed to make. We are not required to estimate it. We have prepared this under the direction of our board. There is not enough leeway in these funds, so it was intentionally left out. The anticipated receipts are funds collected, but not distributed to us yet. We are required to subtract those out, but not the oil & gas. Commissioner Gartner, stated they would review and the levy would be set on Thursday at 10:00 a.m.

Encroachment Permit-An encroachment permit was received for County Road 261. The commissioners could not see that the Road Supervisor had reviewed it and tabled it.

New Business:

3)WIC CONTRACT

WIC Contract-A motion was made to approve the contract presented from the Health Department Director to renew the annual WIC contract for October 1, 2015 through September 30, 2016. \$36,062 to provide services to Dawson, Garfield, McCone, Prairie and Wibaux Counties. The motion was seconded. All voted in favor. Motion carried.

4)FINAL PLAT-BARTHEL'S SUBDIVISION-WHITEAKER

Final Plat for Barthel's Subdivision (Whiteaker)-Dianna Broadie, County Planner reviewed her findings on the final plat with the Commissioners. She recommended approval of the plat, as the preliminary conditions were met. It was noted that the Whiteakers have decided to use the existing well on the second lot and make upgrades to it. The clerk and recorder asked if the upgrades had been made yet. The planner stated that it had previously met MDEQ approval and the upgrades will not need further MDEQ approval. A motion was made to approve the plat. The motion was seconded. All voted in favor. Motion carried.

5)RIVER ROAD

Legal Opinion-River Road Zoning Fund-The Clerk and Recorder read the legal opinion about what could be done with River Road Zoning Fund in order to close it out. According to the opinion, it cannot be closed into the general fund. The zoning and planning commission operates out of the general fund, so there was some discussion about if the money could be given to an advisory committee for River Road Zoning if one were formed. The item was tabled to be further researched.

6)HEALTH CONTRACT-BLOOMFIELD SCHOOL

Health Contract-Bloomfield School-A motion was made to approve the contract for services from the Health Department for the Bloomfield School. They will provide health services for the 15/16 School year for \$479.55.

7)ACTION FOR EASTERN MT WORK PLAN

Action for Eastern Montana Work Plan-The commissioners received a Community Block Grant Work Plan for the years 2016-2017 from Action for Eastern Montana. As a county that receives services, they need to approve the work plan. A motion was made to approve the Work Plan. The motion was seconded. All voted in favor. Motion carried.

Employees on the step and grade will receive a 1% longevity through 30 years of service. Schedules are attached. House Bill 366 was made effective July 1, 2015 where the Clerk of Court and Justice of Peace, in addition to the Clerk & Recorder with Election Administrator duties and the Treasurer may also receive an additional \$2,000 a year. The commissioners have opted to enact this pay. A motion was made to approve the resolution. The motion was seconded. All voted in favor. Motion carried.

10)RES #2015-19 PERMISSIVE HEALTH LEVY

Resolution #2015-19, Permissive Health Levy-A motion was made to approve the Permissive Health Levy for the FY 15/16 in the amount of 8.5 mills for premium contributions to group health insurance. The motion was seconded. All voted in favor. Motion carried.

11)RES#2015-20 COUNTY BUDGET FY15/16

Resolution #2015-20, Adopting the Final Budget for FY2015/2016-The Clerk and Recorded noted that the estimated Oil and Gas Revenue was decreased based on the most recent payment some budget adjustments were made due to that. The Road Fund and Public Safety Fund had cuts made. The other funds had some mill adjustments with other funds and a reduction in reserves. In his opinion, the commissioners did not allow him to get the correct information. As commissioners you have the final say. He was asked me to resolve this. He and Mr. Nix had a good meeting. He thought they had come to an agreement, but in the end we weren't able to. He asked the chair of the County Commissioners to please ask for an Attorney General Opinion. The college has an attorney writing an opinion and he can hire one as well, but he thinks an impartial opinion should be looked at. He thinks this is the best way to go and the most cost effective. His only recourse is to take it to the courts.
